The VA is required to send you advance notice of the need for a reexamination. If you receive a letter from the VA asking you to attend a VA examination for the purpose of evaluating your disability rating, this likely means the VA has decided the medical evidence on file does not support a continuation of your benefits at their current rate.

(b) Compensation cases - (1) Scheduling reexaminations. Assignment of a prestabilization rating requires reexamination within the second 6 months period following separation from service. Following initial Department of Veterans Affairs examination, or any scheduled future or other examination, reexamination, if in order, will be scheduled within not less than 2 years nor more than 5 years ...
